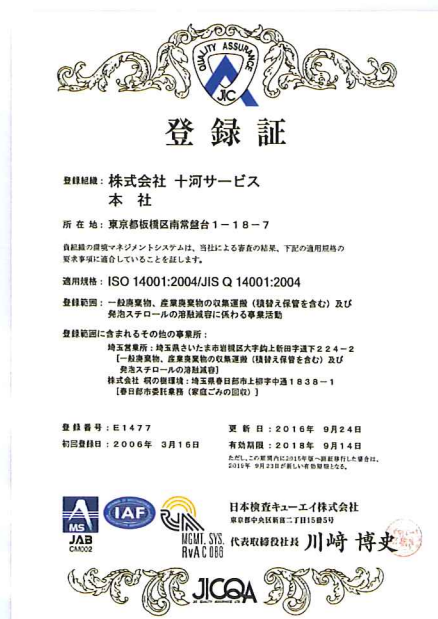

Corporate History

- August 1967 Sogo Service starts business operations at 3-26-20 Sakashita, Itabashi Ward, Tokyo.
- April 1970 The Company is capitalized at one million yen at the same address to become a limited company.
- April 1972 Toda Service Office opens at 1-12-13 Kizawa, Toda City, Saitama.
- October 1977 Fukushima Service Office opens at 10 Kuida, Joban-Sekifune-machi, Iwaki City, Fukushima.
- December 1977 The Company increases the capital to 10 million yen.
- April 1978 Head Office relocated to 3-4-26 Hasune, Itabashi Ward, Tokyo.
- August 1979 Toda Service Office relocated to 225-2 Aza-Michishita, Kagiage-Shinden, Iwatsuki City (present Iwatsuki Ward, Saitama City), Saitama and is renamed Saitama Service Office. Saitama Service Office starts recycling business, introducing dissolvers of styrofoam (recycling business).
- December 1979 Chiba Service Office opens at 2-4-9 Fujisaki, Narashino City, Chiba.
- January 1982 Sogo Service Ltd. is reorganized as Sogo Service Company Limited.
- January 1984 Head Office relocated to 3-4-15 Hasune, Itabashi Ward, Tokyo.
- November 1985 Fukaya Service Office opens at 776 Aketo, Fukaya City Saitama.
- April 1989 Construction of new Head Office building starts.
- May 1989 Fukawa Service Office relocated to 1181-1 Mizuoshiage, Tamai, Kumagaya City, Saitama.
- September 1989 Showa-machi (present Kasukabe) Service Office opens at 439 Sakunouchi, Nishikananoi, Showa-machi, Kita-Katsushika-gun (present Kasukabe City), Saitama.
- December 1989 Construction of new Head Office is completed and Head Office relocated to the present address of 1-18-7 Minami-Tokiwadai, Itabashi Ward, Tokyo.
- April 1992 The Company acquires an intermediate processing plant in Iwatsuki City (present Saitama City), Saitama, which is spun off as an incineration business.
- May 1994 Showa-machi Service Office relocated to 2261-1 Miyashita, Naganuma, Showa-machi, Kita-Katsushika-gun (present Kasukabe City), Saitama.
- June 1994 The Company acquires a license as a common motor trucking business.
- July 1995 The Company expands the coverage of its common motor trucking business to the Tokyo Metropolitan area and Gunma, Ibaraki and Tochigi prefectures.
- November 1996 A magnetic separator is installed at Saitama Service Office to separate off steel and aluminum scrap.
- August 1997 A new recycling plant is built at Saitama Service Office. The Company starts a full-scale recycling business.
- June 1998 Tokyo Service Office opens at 7-2 Iriya, Adachi Ward, Tokyo (and acquires permission to leave waste materials on trucks).
- September 1998 The Company increases its capital to 40 million yen.
- September 2000 The Company acquires land in the industrial area of Iwatsuki City (present Saitama City), Saitama, which is spun off as a waste paper recycling business.
- May 2001 Kawaguchi Service Office opens at 108 M&K Dai-Ichi Building, 3-32-9 Totsuka-Higashi, Kawaguchi City, Saitama.
- August 2001 Omiya Service Office opens at 1429-1 Katayanagi, Minuma Ward, Saitama City, Saitama.
- September 2004 The Company acquires ISO14001 certification, which covers the Head Office and Kasukabe Service Office (former Showa-machi Service Office).
- July 2005 The Saitama Service Office is expanded to Saitama Center with two plant buildings and operation starts.
- July 2005 An administrative office building is completed in Saitama Center and the Showa-machi Service Office is renamed Kasukabe Service Office.
- November 2008 The Saitama Center applies for a permit to expand the disposal business.
- February 2010 The Kasukabe Service Office is spun off as Sogo Service Kasukabe Co., Ltd.
- September 2012 The Company includes the Saitama Service Office within the scope of its ISO14001 certification.
- November 2012 The Tama Service Office opens at 6-22-3 Renkoji, Tama City, Tokyo.
- March 2013 The Company is certified as a good industrial waste disposal business (Saitama, under the category of industrial waste collection transportation business).
- January 2014 The Kanuma Service Office is relocated to 140-3 Nishi-Kanuma-machi, Kanuma City, Tochigi.
- April 2016 The Chiba Center and Yachiyo Service Office open at 1072-1 Shimadadai, Yachiyo City, Chiba.

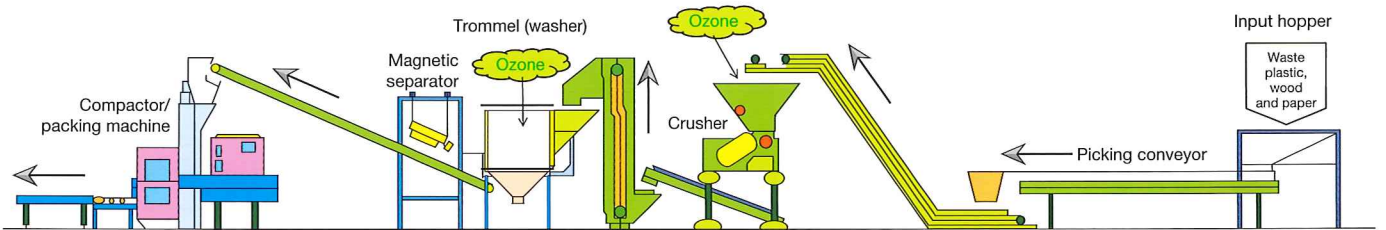
